Terms and Conditions

- (i) The Promoter is LLPMA: Lendlease Property Management (Australia) Pty Limited ACN 002 894 153 of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is 02 9236 6111.
- (ii) Only residents of Australia aged 13 years of age or older (**Participant**) are eligible for the Competition. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the Competition, evidenced by the parent or guardian signing the entry form.
- (iii) The following person(s) are ineligible to enter the Competition:
 1. employees of:
 1. any retailer within Cairns Central;
 2. the Promoter; and
 3. the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies and contractors; or
